If a vehicle is put into service outside of Canada and is plated with non-Canadian plates in contravention of the terms set out above, you agree that Nissan Canada Inc. shall be entitled to: (i) cancel, without notice to you, the delivery of any outstanding vehicle orders, (ii) terminate this Agreement and any agreement related to this Agreement and /or (iii) obtain full re-imbusement from you for any/all monies paid or credited to you (including allowances, bonus or rebates) in connection with this or any related agreement. Any amount required to be repaid to Nissan Canada Inc. under this Agreement shall be paid promptly on demand.

You recognize and agree that Nissan Canada Inc. shall have the right at any time and in its sole discretion to amend or revoke any of the terms and conditions set out in this Agreement without notice or obligation to you.
